

## LI Mobster Indicted In Tax Fraud

Brooklyn—Cosa Nostra member Michael (Midge) Belvedere, 41, of West Babylon, was indicted yesterday by a federal grand jury on three counts of filing false income tax returns.

Denis Dillon, Eastern District Strike Force director, said that Belvedere, who surrendered himself in Federal Court yesterday, was charged with understating his income by a total of \$23,000 in income tax returns for the years 1964, 1965 and 1966. Belvedere pleaded innocent to the three-count indictment and was released in \$5,000 bail by U.S. District Court Judge Jack B. Weinstein to await trial.

Dillon said that Belvedere, a member of the Cosa Nostra crime family of Joseph Colombo, is believed to have taken over the gambling interests of jailed Colombo captain John (Sonny) Franzese, who is serving a 50-year term for his 1967 conviction on charges of conspiracy to rob banks. Belvedere was identified by intelligence officers as a Queens bookmaker who has expanded his operations to Suffolk. He has convictions of assault (reduced from rape), assault and robbery, forgery, attempted larceny and possessing gambling records.

Belvedere, who lives in a \$50,-000 home at 722 Fifth St., West Babylon, allegedly declared income of \$1,300, \$4,000, \$6,000 in the years named in the indictment but made \$23,000 more than that.

### LI Abortions Down by 25% During August

The number of abortions performed in Nassau and Suffolk Counties dropped more than 25 per cent during the second month of the state's new abortion law.

Information from both county health departments showed that most of the 773 women who had abortions in August were white. About half were married.

In Suffolk, which reported 371 abortions in July, there were 277 abortions in August. Nassau reported 694 abortions in July and 496 in August. In both counties, most of the pregnancies were terminated before the end of the 13th week of pregnancy, officials said. Under the new law, which became effective July 1, an abortion may be performed for any reason up to the 24th week.

In Nassau, 442 of the women operated on were white. In Suffolk at least 198 were white. In Nassau 278 of the abortions were for out-of-wedlock pregnancies. In Suffolk at least 112 out-of-wedlock pregnancies were terminated. The new law, one of the most permissive in the nation, has no residency requirements, but the majority of the women were local residents. Although there is no requirement that abortions be done in hospitals, all of Suffolk's and all but three of Nassau's were.
