Miner said that Schiffer had brought disrepute to the legal profession by his tactics in connection with an attempt by three cab drivers whom he was representing to void a contract between Chicago taxi firms and a union that had replaced the Teamsters as the cab drivers' bargaining agent. The judge cited courthouse lobby press conferences featuring what he called "vile and inflammatory charges and predictions" contrary to legal canons, and the apparent retention of Schiffer in the case by direction of a gangsterdominated Teamster local official. However, Schiffer successfully appealed the ban to a federal appeals court.

The judge who ordered the contempt citation against Schiffer was Federal Judge Frank W. Wilson, who ruled that Schiffer "purposely set out, not to avoid error in the trial . . . rather to create error." At one point the fiery Schiffer had described the proceeding against Hoffa as "a drumhead courtmartial" smacking of "Stalinism . . . Hitlerism . . ." At the close of his summation, he threw coins on the prosecutor's table and said, "Here's 30 pieces of silver . . . you earned it."

Schiffer appealed the contempt citation to the U.S. Supreme Court, which refused to review it. Wilson also had impossed a \$1,000 fine in addition to the prison term.

An associate once said of Schiffer's court conduct, "There's no question he's a scrapper. It's as if anything him." Schiffer was outspoken, dramatic, among defense lawyers for East Coast Teamster boss John J. O'Rourke and 13 others on trial in Mineola on charges of using a union local as a device for extorting money from juke-Hoffa, who is serving an eight-year Rackets Committee Chairman John

McClellan (D-Ark.) When the judge replied that some thought McClellan was a wonderful man, Schiffer retorted: "Some think Satan's wonderful."

Schiffer's wife, Pearl, once said, "I'm very proud of him. People don't believe it, they're always looking for an ulterior motive, but he is dedicated to the Constitution and due process of law. He says what he believes he has a right to say."

In addition to his wife, survivors include a daughter, Mrs. Judith Brooks of New York and a son, Robert of Los Angeles.


