Union Aide Is Convicted In LI Case

Brooklyn—A jury in U.S. District Court found a mob-connected Teamster Union business agent guilty yesterday of conspiracy to extort \$1,500 from the president of a Great Neck firm.

Philip Michael Tortorici, 41, of Manhattan, business agent for Teamsters Local 918 in Brooklyn, was found guilty after 10 hours of deliberation. A codefendant, Joseph Barresi, 62, of Elmont, who is secretary-treasurer of the local, was found innocent.

A third defendant, Samuel Schnepper, 52, of Brooklyn, who also is a business agent for the local, pleaded guilty earlier to charges of conspiracy and extortion. U.S. District Judge John F. Dooling is to sentence the two men in about a month.

Tortorici and Schnepper were charged with trying to extort \$1,500 from Stanley Arlin, president of Fisher Service Inc. of 785 Northern Blvd., Great Neck, in return for a "sweetheart" contract covering the 24 employes of his coin-operated laundry business. When Arlin refused the contract, they threatened to destroy his trucks. Their proposed contract would have provided minimal wage increases but no fringe benefits for the employes, who had not joined the union.

Tortorici's uncle, Joseph (Joe Stutz) Tortorici is a soldier in the crime family of Gerardo Catena. Schnepper is the former president of Amalgamated Production Workers Local 88, a union controlled by John (Sonny) Franzese of the Joseph Colombo crime family.

Nassau Man Gets Second 2-Year Term

New York—A labor consultant from Great Neck got a bargain prison sentence in U.S. District Court yesterday: two years to be served concurrently with a two-year sentence that he already is serving.

Judge Charles M. Metzner sentenced Jack McCarthy, 49, of 27 Arleigh Rd., Great Neck, after McCarthy pleaded guilty to a kickback conspiracy to pay \$34,000 to David Wenger, 60, of 101 Grace Ave., Great Neck, for approval of an application for an \$875,000 mortgage from the Teamsters Union pension fund.

McCarthy's new sentence was to have begun on Aug. 3, 1970, the day he began his first sentence for kickback conspiracy.

Wenger, who received a 27-month sentence for his role in the kickback conspiracy that got McCarthy his first two-year sentence, was auditor of the pension fund and was described during his trial as the graft collector for Teamsters president James R. Hoffa. The mortgage was for construction of a hospital in Fairlawn, N.J.
