

End Hearings On Lilco's Bid.

The last of a series of public hearings ordered by the Public Service Commission on the Long Island Lighting Co.'s request for ended yesterday in the World Trade Center in Manhattan with

The decision will be a recommendation to the full Service Commission by Hearing Examiner Joseph Holt, who has conducted hearings that have been held intermittently since September.

The rate hike, if approved, will hit the 393,000 customers served by Lilco in Nassau, Suffolk and parts of Queens.

Rate Breakdown

The utility is seeking the rate hike because of "inflation, increased taxes and the increased cost of doing business," said a -1 Lilco aide.

"Under the new rates," she explained, "a typical residential customer who uses gas for cooking and currently pays \$5.02 per month, would be increased \$1.51. One who uses gas for cooking and water heating and currently pays \$9.79 per month, would pay \$2.36 more. The residential gas-heating customer who pays \$34.49 per month, would pay \$6.74 more."

The final session on the rate hike, held for four months in Hearing Room No. 1 at PSC Headquarters, Two World Trade Center, was marked by two heated exchanges, one between opposing attorneys for Lilco and the PSC, the other between a Lilco official and the lawyer for the State Consumer Protection Board, which sat in on the hear-

Asks Reduction

Charging that Lilco was asking for a greater rate incraese "than it can justify," Arthur B. Cohn, staff counsel for the PSC, moved that the utility reduce its request from over \$19 million to \$17,312,000.

Holt denied the motion after Lilco attorney James Stoker heatedly repeated, "The company is asking for \$19,894,000."

There was another flurry earlier between Lilco manager Bernard K. Kelly and consumer attorney Douglas Redfield ever savings expected on an anticorrosion system.

Dismiss Jury
