

Perjury Charge In Auto Trial

Mineola—Jerome Zimmerman, 43, a former East Meadow auto salesman, was arrested yesterday on a perjury indictment charging that he lied on the witness stand at a trial that involved Michael Franzese, son of imprisoned crime figure John (Sonny) Franzese.

Zimmerman, who gave his address as Woodland Hills Calif., was arraigned on the third-degree perjury charge before Judge Raymond L. Wilkes and released in his own custody. He could get up to a year in jail and a \$1,000 in fine if convicted.

Zimmerman had been indicted with the younger Franzese and five other men on charges of attempting to extort \$1,500 from Franzese's partner in an auto leasing firm. Charges against Zimmerman and Franzese eventually were dropped, and Zimmerman was called to testify in defense of the remaining three defendants. He is charged with lying about what he told a member of the Nassau County Police Department during the investigation of the charges.

Building Safety Order Issued

Riverhead—A developer has been ordered by State Supreme Court Justice William Geiler to make safety improvements on an unfinished four-story building in Melville.

Huntington officials had sought the order last month charging that the building constituted a hazard because pieces of steel and aluminum were likely to blow off and because the open structure attracts children. Geiler concurred and ordered the developer to make the repairs or pay the town to do it.

The developer is Huntington Towers Ltd., 275 Broadway Rd., Melville. Assistant Town Attorney Jerome Wallin said that some repairs have already been completed by the developer.

3 at State U Receive Grants

Stony Brook—Three State University faculty members have been awarded grants totaling \$30,000 by the National Science Foundation to purchase laboratory equipment for undergraduate programs. The three are Rene Chevray of the department of mechanics, Kenneth Short of the department of electrical sciences and Robert Kerber of the department of chemistry. The grants are part of a matching fund to be met by the university.
