# Abortion foes, to the public for help in the case of a hit-and-run accident in South Hempstead Supporters plan rallies tomorrow

Officials of the Diocese of Rockville Centre met yesterday with Bill Baird, the birth-control and abortion rights advocate, at the chancery offices in a discussion of the plans of the two sides for antiabortion and pro-choice demonstrations tomorrow in Hempstead.

Bishop John McGann, the head of the diocese, said he would personally lead a demonstration by 150 parish cluding members of the Napriests, 50 nuns and brothers of local religious orders, and Women, the American Jewother of pro-life activists outside Baird's Center for Women on Fulton Ave. in Hempstead.

The anti-abortion rally is to begin with a prayer service led by McGann in the auditorium of the Sacred Heart Academy on Cathedral Ave. in Hempstead at Noon, said the Rev. James Lisante, the director of the Respect for Life Office of the diocese and the coordinator of the demonstration, called, "A Prayer and Walk for Life."

### Request by Baird

The priests and lay people at the service are expected to then march in a procession outside Baird's center, which fronts on Fulton, but has a parking-lot entrance to the building that is off Cathedral across the street from Sacred Heart Academy.

Baird had requested the meeting with McGann, but met with Lisante and other aides to the bishop for about 40 minutes yesterday. The bishop was not at the discussion.

Lisante said Baird expressed concern over acts of violence against abortion centers elsewhere in the nation and was given assurances that the Diocese planned to conduct a "peaceful prayerful"

demonstration. Baird said after the meeting that he told the priests that "operations would be going on Saturday afternoon during the demonstration and that shouting and catcalls to the patients could cause them stress and led to serious physical complications."

## Asks for quiet

He said he asked Lisante "to keep the demonstraters quiet and to be certain not to

disturb any of the women entering the building."

Baird said supporters of the pro-choice movement, intional Organization ish Women's Congress, and several ministers and rabbis, will conduct a counter-demonstration between noon and 2 p.m. and then hold a prayer service at 4 p.m. in the Presbyterian Church of Roslyn.

Lisante said that McGann decided to lead the demonstration personally in an effort to dramatize the church's desire to have all people develop a "respect for life in all stages, be it a fetus, elderly, homeless, or the handicapped."

# Junge quito i atheto ti di upon defendant's request

A federal judge who slapped a crime-family captain with a stiff sentence 19 years ago stepped aside yesterday in a case involving the capo's son.

Federal Uniondale Judge Jacob Mishler excused himself after lawyers for Michael Franzese, 34, of Brookville, and his codefendants said they would be ready to go to trial in 90

The case was reassigned to Judge Eugene Nickerson and moved to Brooklyn.

Franzese's lawyers had asked for Mishler to step down because of his connection with Franzese's father, John (Sonny) Franzese, who has been identified as an underboss in the Colombo crime family.

Mishler sentenced the

elder Franzese to 50 years on a bank-robbery conspiracy conviction. Franzese served eight years before being paroled.

The younger Franzese, a movie producer, was indicted by a Brooklyn federal grand jury Dec. 19 on charges that he masterminded a rackets ring that defrauded major corporations and government agencies out of \$5 million.

### Hearing postponed

Franzese pleaded not guilty at an arraignment before Mishler on Monday.

Franzese had been returned by federal authorities from Florida, where he was indicted on charges alleging that he had cheated the state of \$40 million in gasoline taxes.

Mishler had ordered Franzese held without bail, pending completion of a

bail hearing, which was canceled yesterday after Mishler stepped aside.

Nickerson is scheduled to continue the hearing Monday.

prosecutors Federal have argued that to release Franzese and his co-defendants, Frank Cestaro, 46, of North Bellmore, and Frank Castagnaro, 40, of Amityville, would pose a danger to witnesses.

The prosecutors produced a convicted swindler, Lawrence Iorizzo, 42, of Dix Hills, who testified that Franzese was involved in discussions to bribe a federal parole officer and to murder Iorizzo's son.

Iorizzo, the former head Vantage Petroleum Corp., is in the governmentprotection prowitness gram. He is expected to be a against witness key Franzese.
