Here is a list of the athletes who entered into a one-year pretrial diversion program for illegally signing representation agreements and accepting money from agents **Norby Walters** and **Lloyd Bloom**. Egypt Allen, 24, Texas Christian, joined Chicago Bears as a free agent during 1987 NFL players' strike, cut by team Tuesday. Jerry L. Ball, 23, Southern Methodist, 1987, drafted by Detroit Lions, defensive lineman. John Clay, 24, Missouri, 1987, first-round draft pick by the Los Angeles Raiders, offensive tackle with San Diego Chargers. Ken Davis, 26, Texas Christian, 1986, second-round draft pick by Green Bay Packers, running back. Charles Faucette Jr., 24, Maryland, 1987, 10th-round pick of New York Giants, now starting linebacker with San Diego Chargers. Brent Fullwood, 24, Auburn, first-round draft pick of Green Bay Packers in 1987, running back. Everett Gay, 23, Texas, 1987 fifth-round pick by Dallas Cowboys. Ronald **Harmon**, 24, **Iowa**, first-round draft pick of Buffalo Bills in 1986, running back. Mark Ingram, 25, Michigan State, 1987 first-round draft pick of Giants, starting wide receiver. Timothy McGee, 24, Tennessee, 1986, first-round draft pick by Cincinnati Bengals, wide receiver. Devon Mitchell, 25, **Iowa**, 1986, defensive back for

the Detroit Lions. Ron Morris, 23, Southern Methodist, second-round draft pick of Bears in 1987, wide receiver. Frankie Neal, 22, Fort Hays (Kan.) State, 1987, Green Bay Packers, pass receiver. Paul Palmer, 23, Temple, first-round draft pick of Kansas City Chiefs in 1987, running back. Garland Rivers, 23, Michigan, 1987, drafted by the Detroit Lions as a defensive back and a member of the Bears for a while. Brad Sellers, 23, Ohio State, Bulls No. 1 draft pick in 1986, starting forward. Tim Smith, 24, Texas Tech, 1987, fifth-round draft pick by the Washington Redskins, set 1988 Super Bowl rushing record. Tony Woods, 22, Pittsburgh, first-round draft pick of Seattle Seahawks in 1987, starting linebacker. Roderick Woodson, 23, Purdue, first-round draft pick of the Pittsburgh Steelers in 1987, starting cornerback last season.
