**Fill-In Gilbert Beats Edberg in WCT Finals**

Brad Gilbert, a late replacement for tournament favorite Boris Becker, upset rusty Stefan Edberg, 7-6 (7-3), 6-1, 6-3, last night in the opening match of the WCT Finals in Dallas. Gilbert needed only an hour and 54 minutes to dispose of Edberg, playing his first match in five weeks after suffering back spasms at the Australian Open.

In a later match, Mikael Pernfors was a 2-6, 6-1, 3-6, 6-2, 6-3 upset winner over fellow Swede Mats Wilander, competing in only his second tournament of the year. Pernfors meets Gilbert tomorrow in the semifinals.

WCT officials called Gilbert at his home in Oakland Monday night when Jimmy Connors, the first alternate, failed to arrive in Dallas and Henri Leconte and Thomas Muster, next in line behind Connors on the basis of qualifying points, were unable to arrange flights from Europe.

Gilbert took a red-eye flight, arriving in Dallas in time for breakfast. He was practicing with a friend at a Dallas country club in mid-afternoon when he received the call that Becker, the hottest player on the indoor circuit, had withdrawn because he was suffering from the flu.

**Britain Curtails The Eagle's Flights**

Eddie (The Eagle) Edwards, who became a celebrity when he finished last in both the 70- and 90-meter ski jumping at the Winter Olympics in Calgary, has been barred from competing in World Cup events, at least for this season. The British Ski Federation said he will be limited to lower-level events for the time being. Edwards is expected to return to action soon after recovering from a shoulder injury suffered in training in December.

"Although Eddie is again fit to jump — and I am delighted to hear the good news — it would be inappropriate for him to launch straight into the high-level World Cup events," the federation's John Leaning said. "We consider it more logical and sensible for him to ease back into the lower-level, 70-meter European events," which take place in early March.

**U.S. Soccer Juniors Lose in Semifinals**

Nigeria beat the United States, 2-1, after 30 minutes of extra time, in the semifinals of the World Youth Cup soccer tournament in Jiddah, Saudi Arabia. Portugal defeated Brazil, 1-0, in the other semifinal of the 19-and-under event and meets Nigeria in the final on Friday.

The Americans and Nigeria were scoreless at halftime and tied 1-1 at the end of regulation. The United States plays Brazil, the pre-tournament favorite, for third place on Friday.

**Lawyer Wants Separate Trials for Agents**

A defense attorney sought to have sports agent Lloyd Bloom tried separately from colleague Norby Walters on federal charges including racketeering and extortion. Both are accused of using cash and threats to line up college athletes as clients.

Defense attorney Dan Webb said he wants to have Bloom tried separately from Walters because their defenses could conflict with each other. U.S. District Judge George Marovich, sitting in Chicago, said he will rule on the motion today before empaneling a jury. "I don't mean to be wishy-washy, but somebody is going to go to trial Wednesday," Marovich said.

**Jersey Tracks to Pay Bonuses**

The Meadowlands and Monmouth Park will pay more than \$1 million in bonuses to trainers and owners of winning thoroughbreds in 1989. Robert E. Mulcahy III, head of the New Jersey Sports and Exposition Authority, said bonuses will be awarded in addition to the money earned in each race. Bonus payments will be made to owners of horses who win allowance races, maiden special-weight races and claiming races carrying a purse of at least \$25,000. Trainers will receive a bonus at the end of the meet if they finish in the top 10 in the standings.

**Furthermore . . .**

Former Spurs star George Gervin went to a hospital in a case being investigated as an apparent drug overdose, the San Antonio Light reported. A hospital spokeswoman confirmed that the 36-year-old Gervin was brought in by ambulance, but she could not elaborate on his treatment. Sources close to Gervin said he has been receiving drug counseling in Virginia . . . Canada's federal inquiry into athletes' use of drugs prompted by the disqualification from the Olympics of sprinter Ben Johnson resumed in Toronto with hints of startling testimony to come. Commission counsel Robert Armstrong said he anticipates that athletes who will testify will admit to steroid use, and he urged that no one be penalized for being candid . . . Punches thrown at referees, tennis balls hurled onto basketball courts, and lawsuits disputing "bad" calls have prompted a bill before the Tennessee legislature seeking more protection for sports officials. The measure would make it a misdemeanor to attack a referee and protects sports officials from lawsuits over judgment calls . . . Mike Hayes' 36 points led the Fairview Flyers to a 144-113 victory over Eldon Butte in the Westchester Pro-Am Basketball League. James Whitt led Eldon Butte with 35 points.
