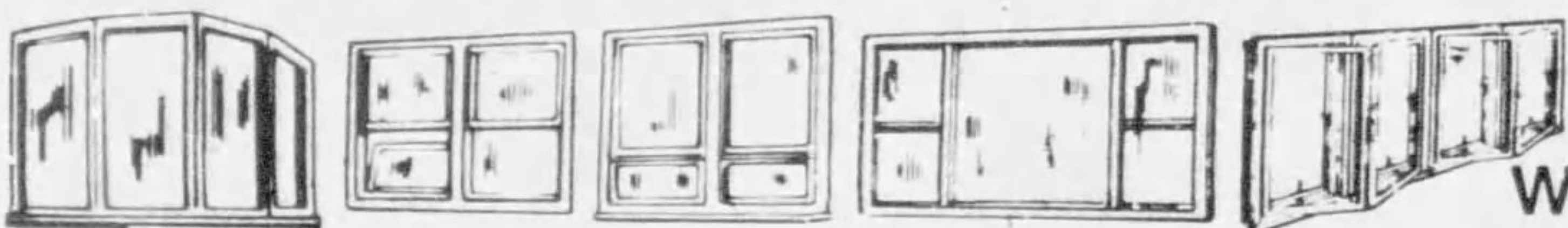

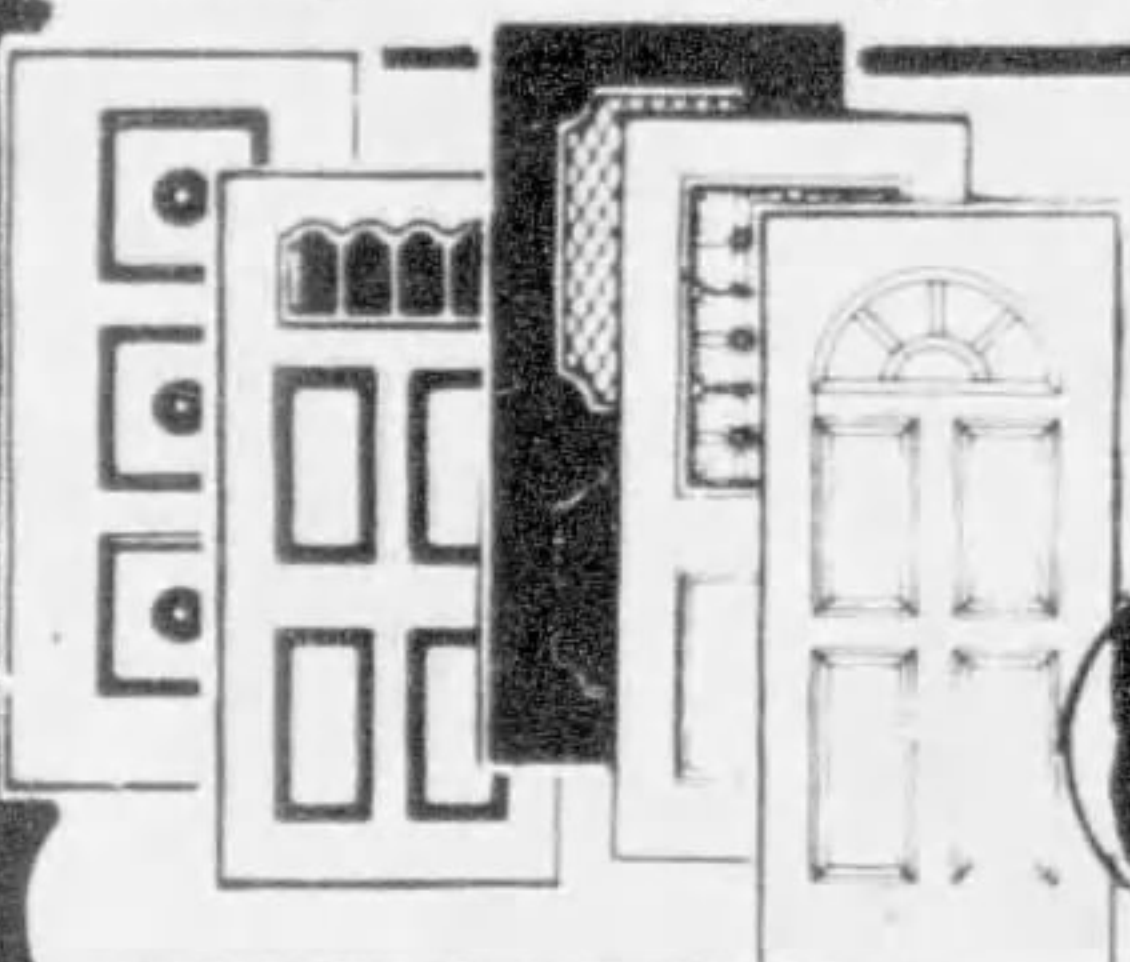

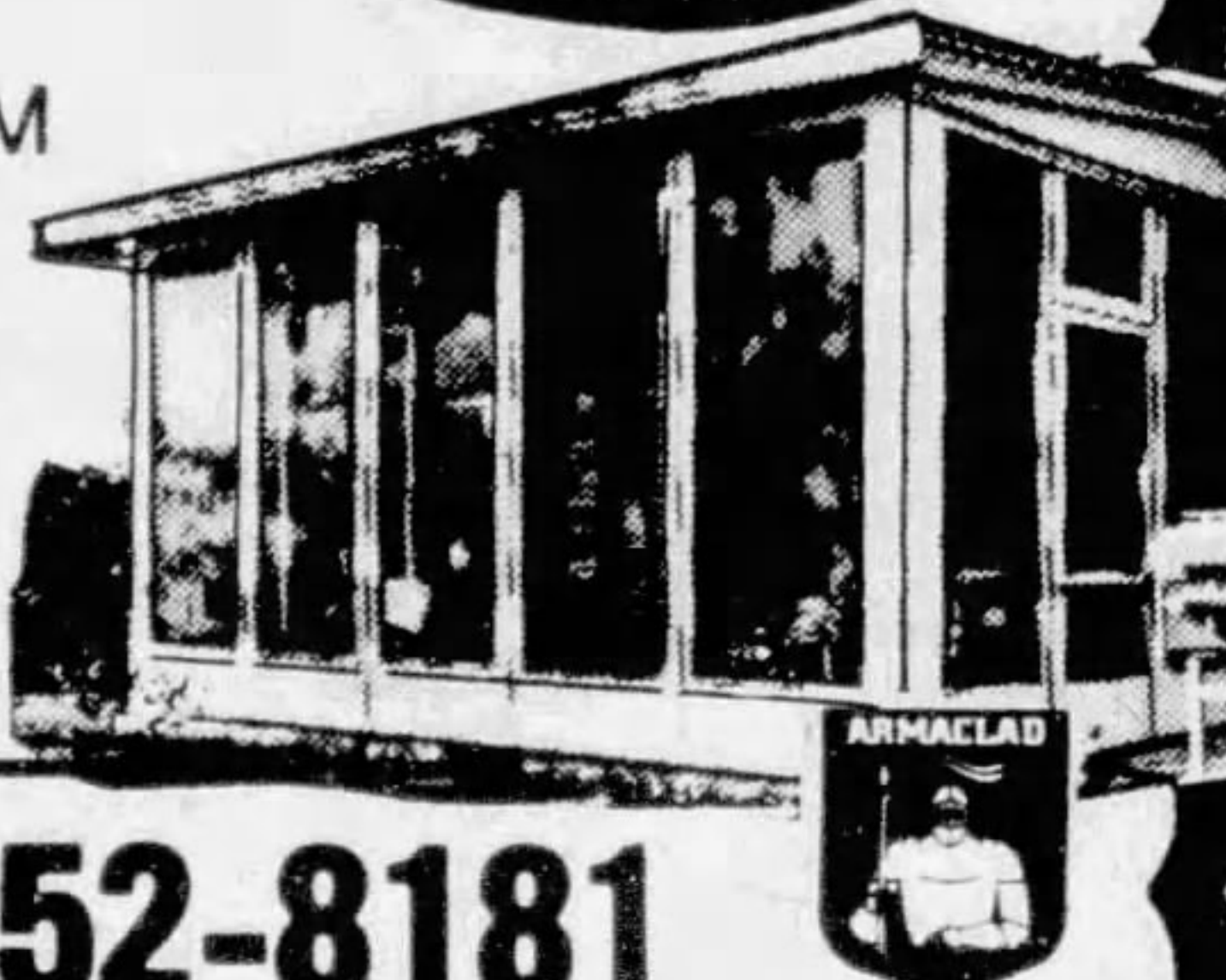

Agent Trial Delayed By Injury to Walters

Defendant Norby Walters suffered an arm injury on his way to the courtroom yesterday, forcing a one-day postponement in his trial on federal charges of defrauding universities and threatening athletes.

Walters was riding the elevator to the 17th floor of Chicago's federal court when he was accidentally knocked to the floor by a cart, defense attorney Dan Webb said. He was taken to a hospital for examination, and U.S. District Judge George M. Marovich delayed testimony in the trial until today.

"He's in good condition. He's being evaluated by the doctors but there's no broken bones. He'll probably be released," a hospital spokeswoman said.

After sending the jury home, Marovich ruled on motions to limit the cross-examination of two government witnesses expected to testify this week — Ron Morris of the Bears and Edwin Simmons, a University of Texas player who never made it to the pros.

Defense attorneys plan to try to impeach Morris' credibility by bringing up under-the-table payments he allegedly received from SMU representatives who recruited him to play college football. The government contends Simmons passed on a threat from Walters' co-defendant and fellow agent, Lloyd Bloom, to another player.

Margo Charged With Shoplifting

Margo Adams, the former girlfriend of the Red Sox' Wade Boggs, was arrested Sunday for allegedly trying to shoplift a \$258 coat from a department store in Costa Mesa, Calif. Police Lt. Alan Kent said security officers took Adams, 33, to the police station in the mall, where she was cited for petty theft, a misdemeanor. She was released on her own recognizance.

It is not Adams' first run-in with the department store. In January, she pleaded guilty to eight counts of using a credit card that was not hers to run up \$4,871 in charges at that store and at other businesses. She was ordered to make restitution and was placed on three years' probation.

Adams, a mortgage broker, is on a nationwide tour promoting a two-part article in Penthouse magazine telling of her affair with Boggs.

U.S. Names Ekiden Quintet

Olympians Steve Scott, Pat Porter and Ed Eyestone have been named to the United States national team that will compete in the America's Ekiden race in New York on April 9. They will be joined by Mark Curp as returning members of the team that competed in the 1988 America's Ekiden in New York — the first ever held outside of Japan. The fifth team member will be Keith Brantly.

Eight other national teams — as well as 50 state teams — are expected to compete in the 50-kilometer road relay that starts and finishes in Central Park.

Baseball. Sal Conti's run-scoring single in the bottom of the seventh gave LIU (1-1) a 6-5 win over Yale in Armand Beach, Fla. Yale (3-7) won the nightcap, 5-2 . . . Hunter's Dan Arndt struck out 10 and allowed four hits and one earned run and David Figueroa had two RBI in a 7-3 victory over Manhattanville.

High School Sports

Baseball. Francis Lewis, paced by Ed Su's two hits and two RBI, overcame a 3-0 deficit to defeat Beach Channel, 6-3 . . . Mike Lourenz hit a three-run home run with one out to go to give Bayside a 6-4 win over Bryant . . . Edison defeated Jackson, 8-3, as Bijan Hunter had a grand slam and five RBI.

Girls Basketball. West Side defeated Brooklyn College Academy, 46-6, in an Alternative League semifinal. Keisha West scored 16 points, Nicky McCrimmon 12 and Kathy Rivera 10 for West Side.

Furthermore . . .

NBC and the International Skating Union agreed on a five-year, \$28-million contract to televise the World Figure Skating Championship beginning in 1991. The contract includes rights to the European Championship, the World Junior Championship and the World Short-Track Speed-Skating Championship. The package has been televised on CBS since 1983 . . . Owners of the six teams in the three-year-old Major League Volleyball have suspended operations because of inadequate operating funds. They said they will try again in 1990.
