Knicks Are Rebuffed Again In Bid to Interview Ferry

The Knicks, seeking to hire a general manager and a director of player personnel, apparently have lost another candidate. For a second time, they were denied permission to negotiate with Washington Bullets general manager Bob Ferry. He was their top GM candidate, according to NBA sources.

"I imagine it's over and done with," Ferry said yesterday, in reference to the prospect of moving to the Knicks.

Richard Evans, president of Madison Square Garden Corp., called Bullets owner Abe Pollin last week seeking permission to interview Ferry, the Bullets' general manager since 1973. As he did a month ago, Pollin declined. Evans was unavailable for comment yesterday.

Meanwhile, former Phoenix assistant Al Bianchi was interviewed yesterday for the second straight day with regard to the director of player personnel vacancy. Bianchi flew back to Phoenix last night and could not be reached for comment. He has stated he would be interested in the job. The Knicks were expected to make an offer, but a spokesman for Evans would not comment.

As for the head coach opening, top candidate Jimmy Rodgers is vacationing in New Hampshire. Rodgers, the Celtics' top assistant, also is interested but has said the Knicks have not made a formal offer.

Dick Motta, another candidate, appears to be out of the picture. "I'm retired and I haven't heard anything from the Knicks," he said yesterday from his home in Fish Haven, Idaho. "The situation is status quo. I haven't heard from them in a while."

Knights Defeat Sugar's Jammers

Micheal Ray Richardson's homecoming was spoiled at SUNY-Old Westbury last night when Richardson's USBL team, the Jersey Jammers, lost a 135-121 decision to the Long Island Knights.

Richardson, released by the Knights June 14, scored 18 points against his ex-team, but connected on just 7 of 20 field-goal attempts.

It was the third straight win for the Knights (11-10). The Jammers fell to 9-12.

Knights president Stan Goldman said that the team will return to Long Island in 1988 but may play somewhere other than in Old Westbury.

Nets' King Has Operation on Knee

Nets guard Albert King was recovering at home yesterday, two days after undergoing surgery to repair torn cartilage in his left knee. King, a six-year veteran of the team, is expected to begin rehabilitation in three to four weeks. Last season he averaged 9.5 points and 3.5 rebounds while averaging 21 minutes of playing time per game. He missed 21 games, the last four because of the knee.

Java Gold Loses by Nose

Trainer Mack Miller would have preferred that the lightly raced Java Gold's layoff of more than two months had been about two weeks longer. Favored at odds of 1-10 with Pat Day up, the 3-year-old Java Gold, one of the favorites to win the Belmont Stakes before becoming ill after a 3-length victory in the April 18 Best Turn Stakes, lost a nose decision to the 5-year-old Cutlass Reality in a mile allowance race at Belmont Park. Java Gold broke on the lead and set a moderate pace on a dull, tiring track but was headed while turning for home by Cutlass Reality and jockey Julio Pezua. They alternated on the lead to the final stride while leaving the three other starters far behind. The running time was 1:36 4/5.

"I'm disappointed he lost," Miller said. "I wish I had two more weeks, but if you want to make the [Aug. 22] Travers you can't wait until July 15. You've got to run now. He has to have some seasoning."

Ditka: McMahon Is No. 1 QB

Jim McMahon will be the Chicago Bears' starting quarterback next season if he's healthy, coach Mike Ditka said. McMahon is in great shape and throwing the ball at about 70 per cent of his normal velocity since undergoing shoulder surgery Dec. 12, Ditka said, adding that the quarterback should be 100 percent when training camp opens Aug. 1.

"He's worked hard," Ditka said. "Now it's just a matter of the arm strength and everything coming back and, once that does, then I think Jim will be the same kind of competitor that he's been for the last five years. And that's been very, very good."

Since adding Jim Harbaugh of Michigan, Chicago's surprise first-round choice in the NFL draft, the Bears have been carrying five quarterbacks, including Doug Flutie, Steve Fuller and Mike Tomczak. But Ditka said that number will drop to three before the season opener against the Giants.

Iowa's Harmon Exonerated

Big Ten Conference officials and a U.S. attorney, after reviewing films of the game, have concluded

that Iowa's Ronnie Harmon did not fumble intentionally in the 1986 Rose Bowl. The all-Big Ten running back fumbled four times in the first half of Iowa's 45-28 loss to UCLA after losing only one fumble during the regular season.

Officials became concerned about the possibility of a gambling scheme, but the NCAA News reported in its June 24 edition that the game no longer is under scrutiny. According to the publication, Assistant U.S. Attorney Howard M. Pearl of Chicago and officials from the Big Ten office studied game tapes and concluded there was nothing amiss.

The Rose Bowl review was an off-shoot of the federal grand jury investigation into the dealings of agents Norby Walters and Lloyd Bloom of New York. Walters has admitted paying Harmon and Iowa defensive back Devon Mitchell while they were still in school.

Bruin's Court Date Put Over

Former Syracuse basketball star Tony Bruin, due in Onondaga County Court in Syracuse on a probation violation, yesterday had his case adjourned until July 30 so authorities can reassess his rehabilitation following a 40-day stint in a drug treatment center. Currently on five years' probation for selling \$420 worth of cocaine to an undercover policeman in Syracuse in 1984, the former all-America guard from Mater Christi High School was charged with violating probation April 8 after testing positive for alcohol and cocaine use.

Ex-Boxer Gets Year in Jail

A judge in Rotterdam, The Netherlands, sentenced former European light-heavyweight boxing champion Rudi Koopmans to a one-year prison term for his role in an extortion scheme. Koopmans, 39, was found guilty of threatening physical violence while working for a debt-collecting firm. Koopmans, who drew a three-month prison term last year for drug trafficking, lost in a 1980 bid to take the WBA championship from Eddie Gregory in Los Angeles.

Top-seeded Paul Cranis of New York routed Al LaMotta of Roslyn Harbor, L.I., brother of former boxing champion Jake LaMotta, 6-1, 6-1, to advance to the semifinals in the 50-and-over division of the Eastern Masters Championships in Glen Cove, L.I.
